- 2. Adoption of agenda: Motion to accept from Carrera, 2nd by Elliot, all in favour, carried.
- 3. Adoption of January 2015 board meeting minutes. Motion to adopt minutes Melissa, 2nd by Sandy, all in favour, carried.
- 4. Correspondence:

 - a) 2015-2016 Season ADC chose submissions for the season and will submit their report for inclusion in minutes.
 - b) Risers: Sandy presented a proposal from Janet Schlackl for Capitol Sea Notes/Glee and

Wee Glee risers. Cost estimate \$3811.29, Glee Contribution \$2000.00, ASK from PPDS \$1811.29. Motion to approve the contribution of \$1811.29 for the purchase of choir risers by Chris and 2nd by Carrera. All were in favour.

- c) Fundraising: Motion by Sandy that PPDS would run 2 50/50 draws during STAGES shows to raise funds to support bursaries for potential Stages students. 2nd by Carrera. 50/50 for Virginia Wolff to "Raise the Reds" (purchase new stage curtain. Elliott will call Stagefab to get a quote.
- d) Strategic Planning Committee will create a maintenance schedule and 'wish list' for the theatre to save toward. i.e. Stage resurfacing.
- e) NIZ Festival: On March 15th PPDS delivered a Tech Orientation to participating clubs.
- f) Board meeting dates have been changed to the 2nd Tuesday of each month to ensure financials from previous month is complete for presentation.
